

Revision to BAGO Operating Procedures

Why?

- Last revised in 2006
- Operating Procedures should be consistent with current activities as they are, not as we wish they would be

What?

- Revising elected officers/members of the voting Executive Board
- Eliminating positions no longer active
- Renaming positions to be consistent with other Chapters/National
- Revising terms of office so that elections are held every 2 years

NOTE: A Chapter does not require Bylaws (per AGOHQ)
